The Management of **Bhavya Cements DAV School, Tangeda, Dachepalli, Mandal, Palandu District**, has submitted an application seeking grant of recognition for Classes VI to X (English Medium) for the Academic Years 2023-2024 to 2031-2032, along with a request for condonation of delay for the academic years 2022-2023 to 2025-2026 (4 years).

On verification of the proposals, **Bhavya Cements DAV School, Tangeda, Dachepalli, Mandal, Palandu District** recognition was previously accorded to classes VI to X (EM) upto the academic year 2021-2022 without aid in the reference (5) read above and the recognition was lapsed for the further period.

Further, the District Educational Officer, Palnadu District has recommended the proposals for grant of Recognition to classes VI to X (EM) from the academic year 2022-2023 to 2031-32 (10 Years) duly requested to condone the delay for the Academic Years 2022-2023 to 2025-2026 (4 years).

After careful examination of the above said proposals and the conditions prescribed in rule 10 (24) of G.O. Ms. No. 1 Edn, dated 1-1-1994, G.O.Ms.No.41 Edn, dated 11-05-2006, G.O. Ms. No. 74 Education dated 11-09-2006, and as per the instructions issued by the Government/Commissioner of School Education, Andhra Pradesh, Amaravati in the references 1st to 4th read above, the Regional Joint

Director of School Education, Guntur is hereby accords Recognition to classes VI to X (EM) **from the academic year 2022-2023 to 2031-2032 (10 years) duly condoned the delay for the academic years 2022-2023 to 2025-2026** in respect **Bhavya Cements DAV School, Tangeda, Dachepalli, Mandal, Palandu District**. However by the end of April every year, the educational agency shall file an affidavit to the effect that there is no deviation or violation of norms/rules prescribed by the Government from time to time and the management is requested to comply with the following without fail.

1. That the society shall abide the instructions, rules and regulations made by Government or authorized officer from time to time.
2. That the Educational Institution shall serve the needs of the locality more particularly.
3. That the instructions shall adopt the curriculum and syllabus prescribed from time to time.
4. The school timings, vacation and mid-term holidays shall be as prescribed by the Government from time to time.
5. That the qualified staff within the age limits prescribed by Govt., for Govt., employees shall be appointed as per the Staff pattern.
6. That the results of the Institutions shall be satisfactory every year.
7. That the records /accounts shall be furnished to the D.E.O every year.
8. That the list of Governing body shall be furnished to the D.E.O. every year.
9. That the pay structure/fee structure fixed by the governing body shall be got approved by the D. E.O. every year.
10. That all the conditions prescribed in G.Os and other orders which are not specified in this order shall be complied with.
11. That the school shall not be closed without giving notice both to the parents/DEO and competent authority at least 6 months before.
12. That the school shall be closed or permitted to close only from the date on which summer vacation is declared.
13. That the society shall submit proposal for Renewal of Recognition sufficiently in advance i.e., at least 6 months prior to the date of expiry of the renewal of recognition.
14. The recognition now given is purely on a temporary basis and is subject to the reports of State Level Inspection and Vigilance Committee fulfilling of all the prerequisite conditions under the A.P. Education Act, 1982 and if later found that the School has not fulfilled any prerequisites as stipulated, the recognition now being given is liable to be withdrawn at once.
15. The Management is requested to follow the instructions of the Fire Service Department and renewal the Fire Certificate from time to time without fail and submit the same to this office through the Deputy Educational Officer, Guntur and District Educational Officer, Guntur.
16. The Management is requested to renewal the Vehicle Fitness

Certificate, NOC issued by the Fire Services Department, NOC issued by the Traffic Police, Structural soundness certificate and Sanitary certificate every year from the concerned authorities without fail and submit the same to the District Educational Officer, Guntur through the concerned Deputy Educational Officer, Guntur, Guntur District.

17. Economic Strength should be maintained in all classes and it should be improved during this Academic year.

Further, the managing committee of the school is requested to fulfill all the requirements to cope up with the needs of the institution at the latest before submitting the application **in online** for Renewal of Recognition for the year 2032-2033.
