In the reference 3rd cited, the Government have accorded permission in respect of **Bhavya Cements DAV School, Tangeda, Dachepalli(M)** for opening of classes I to X (EM) at a stretch during the academic year **2012-13** without aid.

The **Mandal Educational Officer, Dachepalli(M)** submitted the proposals for grant of Provisional Recognition in respect of **Bhavya Cements DAV School, Tangeda, Dachepalli(M)** for classes **I to V (EM)** for a period **10 years** i.e., **from 2012-13 to 2021-22** vide reference 4th cited.

The District Educational Officer, Guntur has verified the application for Provisional Recognition with reference to the inspection report of the inspecting Officer and also with the reference to the conditions laid in permission orders issued in the Proceedings read above and Govt., orders issued in the 1st and 2nd read above.


After careful examination of the proposals vide reference 4th cited, and the conditions prescribed in the G.Os 1st and 2nd read above, the District Educational Officer, Guntur is hereby accorded for Grant of Provisional Recognition for a period of **10 years** to classes **I to V (EM)** commencing from the academic year i.e., **from 2012-13 to 2021-22** in respect of **Bhavya Cements DAV School, Tangeda, Dachepalli(M)** subject to the fulfillment of the following conditions.

- 1) That the society shall abide by the rules and regulations made in the Government orders in 1st to 2nd read above cited above and also issued from time to time.
- 18) That the Educational Institution shall needs of the locality more particularly.
- 19) That the Institution shall adopt curriculum and syllabus prescribed from time to time by the Govt., of AP.
- 20) That the school timings, vacations and mid terms holidays shall be prescribed by the government from time to time.
- 21) That the qualified staff with in the age limits prescribed by the Government for Government employees shall be appointed as per the staff pattern.
- 22) That the results of the institution shall be satisfactory of every year.
- 23) That the records / accounts, annual administrative report along with the audited accounts should be submitted to the District Educational Officer, every year.
- 24) That the list of Governing Body shall be furnished to the D.E.O., every year.
- 25) That the pay structure / fee structure fixed by the Governing body shall be submitted to the District Educational officer every year.
- (10) That all the conditions prescribed in the G.Os and other orders which are not specified in this orders shall be complied with.
- (11) That the school shall not be closed with out giving notice both to the parents / Dist.Edni,Officer, and the competent authority at least 6 months before.
- (12) That the school shall be closed (or) permitted to be closed only from the date on which summer vacation is declared.
- (13) That the society shall submit proposals for renewal of Provisional Recognition sufficiently in advance i.e., at least 6 months prior to the date of expiry of recognition.
- (14) The school management shall submit an affidavit every year with regard to non-violation of rules / regulations prescribed by the Government from time to time.
- (15) That the management shall obtain renewal of NOC from Fire Service Department every year and produce for verification as and when requested.
- (16) That the management shall obtain renewal of NOC from Executive Engibneer, R&B concerned from time to time and produces for verification as and when requested.



Educational Officer, Sattenapalli has recommended for Provisional Recognition to Classes VI to X (E.M) from the year 2012-2013 to 2021-2022 vide letter 3rd read above. The District Educational Officer, Guntur District has verified the application for Grant of Provisional Recognition with reference to the Inspection Report of the Inspecting Officer and also with the reference to the conditions laid down in the permission orders and G.,O.Ms.No:1 Edn., (PS-I) Rules Department Dt:1-1-1994 and submitted a report in his letter 4th read above.

After Careful examination of the references read above and the conditions prescribed in G.O.Ms.No: 1 Edn., Dt:1-1-1994, G.O.Ms.No. 41 Edn. Dt: 11-05-2006 and G.O. Ms. No. 74 Education, Dt: 11-09-2006 and as per the instructions issued by the Commissioner and Director of School Education, Andhra Pradesh, Hyderabad in the reference 10th cited, the Regional Joint Director of School Education, Guntur here by accords for Grant of Provisional Recognition to Classes VI to X (E.M) for a period of 10 (Ten) Years ie., from 2012-2013 to 2021-2022 in respect Bhavya Cements DAV School, Tangeda, Dachepalli (M), Guntur District without aid now or in future. However by the end of April every year, the Educational Agency shall file an affidavit to the effect that there is no deviation or violation of norms/rules prescribed by the Government from time to time and the management is requested to comply with the following without fail.

1. That the society shall abide the instructions, rules and regulations made by Government or authorized officer from time to time.
2. That the Educational Institution shall serve the needs of the locality more Particularly.
3. That the instructions shall adopt the curriculum and syllabus prescribed from time to time.
4. The school timings, vacation and mid-term holidays shall be as prescribed by Govt. from time to time.
5. That the qualified staff with in the age limits prescribed by Govt., for Govt., Employees shall be appointed as per the Staff pattern.
6. That the results of the Institutions shall be satisfactory every year.

7. That the records /accounts shall be furnished to the D.E.O every year.
8. That the list of Governing body shall be furnished to the D.E.O. every year.
9. That the pay structure/fee structure fixed by the governing body shall be got approved by the D. E.O. every year.
10. That all the conditions prescribed in G.Os and other orders which are not specified in this orders shall be complied with.
11. That the school shall not be closed without giving notice both to the parents/DEO and competent authority at least 6 months before.
12. That the school shall be closed or permitted to closed only from the date on which summer vacation is declared.
13. That the society shall submit proposal for renewal of provisional recognition sufficiently in advance i.e., at least 6 months prior to the date of expiry of the renewal.
14. The Recognition now given is purely on a temporary basis and is subject to the reports of State Level Inspection and Vigilance Committee fulfilling of all the prerequisite conditions under the A.P. Education Act, 1982 and if later found that the School has not fulfilled any prerequisites as stipulated, the Recognition now being given is liable to be withdrawn at once.
15. The Management is requested to fulfill conditions stipulated in G.O. 8th read above within 3 months and submit compliance.
16. The Management is requested to renew the District Fire Officer Fire Certificate every year time to time.
17. The Management is requested to renew the Structural Soundness Certificate every year from the Executive Engineer P.R / Executive Engineer R&B without fail.

Further, the managing committee of the school is requested to fulfill all requirements to cope up with the needs of the institution at the latest before submission of application for extension of Temporary Recognition for the year 2022-2023.
